Re-entry will be managed by local elected officials and law enforcement officers. Those moving essential commodities and services will need to have the following items:

- o Valid government-issued ID, such as a driver's license or passport;
- o Proof of employment, such as Employer credentials or a letter on employer letterhead; and
- A demonstrated need to enter the area, such as a work order, inventory list, or employer authorization.

Food / Water (as of October 5, 2022)

- Department of Children and Families is pursuing the following federal waivers to assist with food assistance benefits (SNAP)
 - Automatic replacement of 70% of September food assistance benefit for Floridians impacted by Hurricane Ian who did not receive an early release of SNAP. And, the ability to use SNAP benefits to purchase hot food
- Boil water advisories are still in effect for parts of 23 counties; residents urged to converse
 water and reach out to local utility or county emergency contact for most up-to-date
 information
- 28 POD sites operating and distributing food and other supplies in 7 counties
- State is coordinating four barges to aid in the delivery of commodities in Lee County to Pine Island and Sanibel Island

Fuel (as of October 5, 2022)

- Port Charlotte and Cape Coral, Florida are still experiencing significant gas station closures due to power outages or limited fuel supply
- All ports and terminals are open for fuel and many gas stations have begun receiving shipments. Additionally, two residential fuel agencies are open; one in Dunbar, Ft. Myers and one in Arcadia. Cars can get up to 10 gallons per day; trucks can get up to 50 gallons per day
- Mobile, public fueling station opened today in Lee County at Stars Complex to provide fuel for vehicles and gas cans for generators to impacted residents
- FDEM has 8 active fuel depots throughout central and southwest Florida to ensure first responders have the fuel they need to conduct search and rescue operations. More than 1.4 million gallons of fuel have been mobilized.

- **Airbnb** has launched a special website to help Hurricane Ian Relocation efforts for impacted residents at <u>Airbnb.com/hurricaneianflorida</u>. The page features open (vacant and available for rent) properties that are available to be booked outside of the FEMA Disaster zones. As communities become fully restored with water and electricity, Airbnb will add more open properties to <u>Airbnb.com/hurricaneianflorida</u>.
- For Florida residents displaced due to Hurricane Ian, **Airbnb** is also working with their nonprofit partners to offer vouchers for temporary housing at Airbnb properties. AT&T

- AT&T is waiving talk, text, and data overage charges for AT&T Postpaid & PREPAID customers with billing addresses in 828 zip codes across Florida from September 28, 2022, through October 28, 2022, to keep customers connected before, during and after any major storm event.
- To assist the recovery, AT&T is now welcoming other carriers' customers to roam on AT&T networks so they can connect, even if their carrier's service isn't available after the storm. Once this roaming begins, customers will automatically be connected to AT&T network.

Charter Communications

• Charter Communications has opened nearly 175,000 Spectrum Out-of-Home WiFi access points across Florida, Georgia and South Carolina in support of preparation for and response to Hurricane Ian. Information on how to access the points is here.

Prior to closing stores impacted by the storm, Publix donated perishable products to local police, firefighters, and emergency response teams, and also ensured that associates that work nearby and prepared these stores for the storm received donated products.

These assets are staged just outside of the impact area and will be deployed as soon as it is safe to do so.
